WHAT TYPE OF GIFT CAN I LEAVE?

There are several ways you can leave a gift in your will:

- Residuary Gift – A percentage of your estate after other gifts and expenses.
- Pecuniary Gift – A fixed amount of money.
- Specific Gift – A particular item such as property, shares, jewellery or artwork.

HOW TO LEAVE A GIFT IN YOUR WILL

Leaving a legacy gift is simple. Just follow these steps:

- Speak to a solicitor or will writer
- They'll help you write or update your will correctly.
- Include our charity details
- Make sure your solicitor includes the following wording:
- "I give [insert % or amount] of my estate to Enrych (Registered Charity Number 1088623), of The Marlene Reid Centre, 85 Belvoir Road, Coalville, LE67 3PH, to be used for its general charitable purposes."
- Let us know (optional)
- If you've chosen to leave a gift to Enrych, we'd love to thank you personally.
